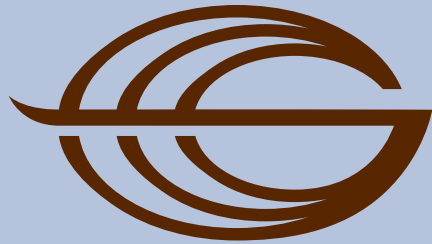

The Golden Long-term Economic Advancement Foundation (L.E.A.F), Inc. was created by the General Assembly to manage one-half of North Carolina's share of funds from the Master Settlement Agreement with tobacco companies.

The 15-member Board of Directors is appointed by the North Carolina Governor, the President Pro-Tempore of the Senate, and the Speaker of the House of Representatives.

The Foundation is dedicated to the long-term economic well-being of tobacco-dependent, economically distressed and rural North Carolina communities.

Golden LEAF makes grants to 501(c)(3) nonprofits and governmental entities. Its priorities include agriculture, job creation and retention, and workforce preparedness. The Foundation also funds projects that provide education and other opportunities to support and develop economic growth in tobacco-dependent, economically distressed, and/or rural communities.

In 2008, the Foundation awarded 102 grants totaling \$129,126,336 to eligible entities. [Click here to see 2008 grants.](#)

To the people of North Carolina —

There is no doubt that these are very tough economic times. It will take hard work, determination, and creativity on the part of all of us to build the North Carolina we want to have.

Recently, the Golden LEAF Board of Directors took bold action to address our challenges. Rather than shrink our grantsmaking efforts, the Board authorized new initiatives, new funding strategies and new ways of doing business.

While other foundations have been forced to reduce their grantsmaking, Golden LEAF will maintain its giving. For the coming year, the Board:

- Strengthened its commitment to Tier One counties across North Carolina with up to \$35 million for its Community Assistance Initiative;
- Provided \$10 million in economic assistance for projects across North Carolina that create or add substantial jobs and investment;
- Provided \$10 million for the development of two new initiatives: (a) to grow North Carolina agriculture jobs, markets and farm income through special focus and (b) to ensure that the growing aerospace industry has the highly-qualified workers it needs to hire now;
- Created a new \$3.5 million initiative to provide the necessary training to get North Carolinians to available good-paying jobs as quickly as possible;

- Earmarked over \$3 million for scholarships for children from rural counties, especially farm families, to attend college;
- Replaced the annual grants cycle with an Open Grants Program. The Open Grants Program will allow for acceptance of year-round proposals, ensure faster decisions from the Golden LEAF Board, and reduce administrative burden for our grantees;
- Almost doubled direct Foundation investment in Tiers 1 and 2 counties through Access Capital, an investor in community-development projects in rural areas;
- Provided \$5 million to support the creation of a new loan-guarantee program to leverage over \$25 million in new loans for qualified businesses needing access to capital in these tough times;
- Committed to seek ways to complement the federal stimulus package, in order to make sure North Carolina gets the full benefit; and
- Cut the Foundation's administrative budget substantially to allow more resources for grants.



Grant Opportunities & Initiatives

Golden LEAF is a foundation dedicated to funding projects that pledge to bring significant economic improvement to the tobacco-dependent, economically distressed, and/or rural communities of North Carolina.

Golden LEAF currently has three programs open to all eligible entities seeking grants: *Open Grants Program*, *Economic Catalyst Cycle* and *Golden LEAF Opportunities for Work (GLOW)*.

The Foundation also has a process targeting the needs of Tier 1 designated communities: the *Community Assistance Initiative*.

For the fiscal year 2010, the Board of Directors earmarked \$10 million for special initiatives in agriculture and aerospace that will reflect the current needs and priorities of these industry sectors, especially as they relate to jobs. The Foundation is currently working on finalizing priorities for these initiatives. Open Grants Program

The Open Grants Program places high priority on the areas of agriculture, job creation and retention, and workforce preparedness. Projects that focus on other opportunities to support and develop economic strength in tobacco-dependent, economically distressed and/or rural communities are also welcomed. In light of the economic downturn, Golden LEAF will be looking for opportunities to complement and leverage federal and state stimulus programs to increase the impact of its grantsmaking on targeted communities.

The Open Grants Program will begin July 1, 2009 and replaces the former Golden LEAF Annual Grants Cycle. This program will make it easier for applicants to submit proposals to Golden LEAF and make funding opportunities available throughout the year. *For more information on the Open Grants Program and how to apply, click here.*

Economic Catalyst Cycle

The Economic Catalyst Cycle is a program that focuses on job creation and/or retention projects associated with business locations or expansions in North Carolina that are at risk without participation from Golden LEAF. Projects submitted by eligible entities must meet specific criteria to be considered for funding.

Golden LEAF Opportunities for Work

Golden LEAF Opportunities for Work (GLOW) is a short-term, non-degree, workforce development grant initiative that supports vocational and/or technical training programs targeting identified employment opportunities in tobacco-dependent, economically distressed and/or rural communities. Workers trained through this initiative should become eligible for immediate placement in permanent, full-time jobs requiring their new skills.

Golden LEAF Opportunities for Work has three deadlines annually for as long as funds are available: April 30, June 30 and August 31.

Community Assistance Initiative

The Golden LEAF Community Assistance Initiative is a grants program that targets communities of need and provides direct support for projects that significantly enhance the quality of life for citizens within those communities by stimulating economic activity or providing assistance in overcoming barriers to economic transition or community progress. The Community Assistance Initiative currently targets North Carolina's Tier One counties (*click here to see your county's Tier designation*) which are considered the most economically distressed counties in the state.

With Golden LEAF staff and board members working directly with county leaders and citizens, proposals are developed following a process whereby the community reaches consensus on the key issues and objectives that it would like to target and then establishes a priority list of projects that have the most potential for positively affecting the key issues and achieving the desired objectives. There is a reserve of \$2 million per county, but grant award amounts may vary. Agriculture and Aerospace Initiatives

The Foundation Board of Directors has earmarked a combined \$10 million for the development of two new initiatives: (a) to increase North Carolina agriculture jobs, markets and farm income in specific areas and (b) to ensure that the growing aerospace industry has the highly-qualified workers it needs to hire now. The Foundation is working to finalize priorities for these initiatives. *Check the Golden LEAF website for updates.*

Financial Markets Initiative

The Foundation Board of Directors has earmarked \$5 million to provide access to capital for North Carolina businesses. Tight credit has held back economic opportunities and the Foundation will leverage other private and public efforts to get capital flowing.

In 2008, the Golden LEAF Foundation was in transition. The Foundation was making changes in its leadership and reevaluating its programs. It made its largest grant award since inception, which alone created over 1,000 jobs. The Board ramped up its Community Assistance Initiative, a grant process directly assisting Tier 1 counties. It also refined the N.C. 1:1 Laptop Initiative pilot program, a partnership with NC organizations to provide computers to students and teachers across the state, primarily focusing on rural communities.

As the Foundation has modified its strategies, it remains steadfast to its commitment to the economic advancement of tobacco-dependent, economically distressed and rural North Carolina communities.

CY 2008 Grant Info

In 2008, the Golden LEAF Foundation awarded 102 grants totaling \$129,126,336 to a diverse set of projects for job creation and retention, workforce training, scholarships, agriculture, technology for high schools and community development.

The grant awards are broken down according to the following Golden LEAF grant programs/ initiatives:

- 59 Annual Cycle grants totaling \$10,358,273 to organizations in 33 counties,
- 12 Economic Catalyst Cycle grants totaling \$104,936,904 to organizations in 12 counties,
- 22 Community Assistance Initiative grants totaling \$9,081,152 to organizations in 5 counties,
- 3 grants totaling \$3,104,000 for student scholarships to NC colleges and universities, and
- 6 grants totaling \$1,646,007 to organizations for other Foundation initiatives.

Below are descriptions of several of the Foundation's special projects and initiatives.

Golden LEAF has formed a partnership with SAS, the Department of Public Instruction, the Friday Institute and the General Assembly called the NC 1:1 Learning Technology Initiative. The goal of the Initiative is the utilization of technology to improve teaching practices, increase student achievement, and better prepare students for work, citizenship, and life in the 21st century. The pilot program includes high schools from 11 school districts. Golden LEAF and its partners are supporting 14

additional school districts in the planning stages for technology initiatives as a part of an overall instructional reform effort. The initiative will benefit 772 classroom teachers and 11,450 students. Golden LEAF has awarded over \$8 million for projects in the NC 1:1 Learning Technology Initiative.

In 2008, Golden LEAF continued its support of the NC Aerospace Alliance, a government and industry partnership established to help generate opportunities for NC companies to manufacture spare parts for aging military systems. The Alliance will both strengthen the military contracting capabilities of NC companies and leverage the military's presence in NC for the creation of jobs and economic opportunity in the State. Golden LEAF has awarded 6 grants totaling \$11,063,336 towards this initiative. To date, it is estimated that 1,358 new jobs have been created and 75 jobs retained with the support of this initiative.

Golden LEAF's largest award to date – \$100,000,000 grant to the Global TransPark Authority in Kinston – is expected to create over 1,000 full-time jobs with Spirit AeroSystems. Spirit has pledged to create these jobs over a six-year performance period. The average wage at the manufacturing plant will be \$48,122 a year. Additionally, the construction of the new facility is creating the equivalent of 800 new jobs for North Carolina businesses. The 800 construction-related jobs will pay an average of \$36,000 a year and will last about 18 months.

As of April 2009, the Foundation awarded 762 grants totaling over \$374 million since its inception.

Financials

The Foundation's financial statements undergo an annual audit, which is conducted by Ernst & Young, LLP. They audited our financial statements for the years ended June 30, 2008 and 2007, which are presented in conformity with the accounting principles and reporting guidelines established by the Governmental Accounting Standards Board (GASB), and expressed an unqualified opinion on these financial statements.
